**ACU PERSONAL ACCIDENT BENEFITS FOR COMPETITORS

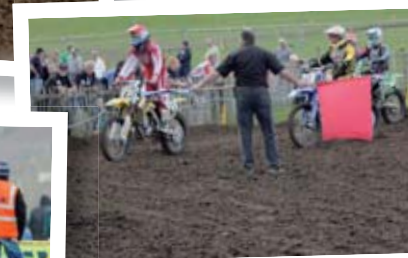
Premier Cover provides 'Industry Standard' Accident Benefits for those participating in ACU Permitted events:

- £10,000 Death Benefit
- £20,000 Permanent Total Disablement
- £40,000 Quadriplegia injury
- £2000 following hospitalisation for 4 weeks or more following injury
